## **Asia/Pacific Airport Coordinators Association (APACA)**

Minutes of 19th Meeting of APACA
12 November (Tuesday), 2019

#### 1. Administration

The nineteenth general assembly meeting of APACA was held at Room "M3" on the Mezzanine Floor, Brisbane Convention Center (BCEC) from 17:00 to 18:00 on 12 November (Tuesday) 2019 at the

occasion of IATA 145<sup>th</sup> Slot Conference in Brisbane, Australia. The chair person, Ms. Petra Popovac (ACA - Airport Coordination Australia), welcomed the participants and expressed her appreciation for attending the nineteenth meeting of APACA under the Worldwide Airport Coordinators Group (WWACG). The meeting was progressed according to the agenda items shown in Appendix 1.



The number of participants was 30 representing 11

economies and 16 organizations which constitute more than half of the entire economies and organizations in the Asia/Pacific region. The list of participants is shown on the last page. Thus, the nineteenth general assembly meeting of APACA formed a quorum.

## 2. Agenda Item 1: Approval of Minutes of 18th meeting

The minutes of the eighteenth general assembly meeting of APACA held on 18 June (Tuesday) 2019 at "Roof Terrace" on the Level 2, Second Floor, Cape Town International Convention Center (CTICC), Cape Town, South Africa was endorsed by the meeting without adjustments.

#### 3. Election Results of WWACG

Mr. Takeda (JSC - Japan Schedule Coordination) reported the election results of WWACG using the material shown in Appendix 2. There were 7 nominees for 7 seats of Board of WWACG. Thus, there was no secret ballot took place at WWACG Plenary Meeting. 4 board members are from Europe, 2 are from Asia/Pacific



and 1 is from North America representing the good geographic balance.

He also reported three volunteers for Slot Board Management Team which will support the activities of Worldwide Airport Slot Board (WASB). 2 volunteers are from Europe and 1 volunteer is from Asia/Pacific representing good geographic balance.


#### 4. Agenda Item 3: Priority Scheme at Initial Allocation (WSG 10th Edition)

Mr. Takeda reported the priority scheme at initial allocation (WSG 10<sup>th</sup> Edition) using the material shown in Appendix 3.

He compared the current priority with new priority scheme at initial slot allocation.

- ① The current priority scheme is that the first priority is historic slots and the second priority is historic change requests. Once historic slots and historic change requests are allocated, the coordinator will establish the slot pool including any newly created slots. 50% of slots in the pool must be allocated to new entrant.
- ② The new priority scheme is that the first priority is historic slots requested as unchanged. Once unchanged historic slots are allocated, the coordinator will establish the slot pool including any newly created slots. The coordinator will treat new entrant requests, non-new entrant requests and requests for changes to historic slots holistically and fairly across the day. 50% of slots in the pool must be allocated to new entrant. Similarly, 50% of slots in the pool must be allocated to non-new entrant request. If the 50/50 balance is not achievable in a single season, the coordinator should correct this imbalance over the next equivalent season.
- ③ He then quoted the material which was prepared by IATA. IATA was planning to host the workshop regarding WSG 10 (New Entrant Rule and Allocation Priorities) for three days, in the morning time of 12

(Tue), 13 (Wed) and 14 (Thur) November. The material focused on "Why have the priority changed?", "How have the priority changed?" and the comparison of WSG 9 and WSG 10. The comparison table to the right which was initially prepared by IATA was changed to new one as a result of discussion with IATA and WWACG. There are still confusions regarding the interpretation of priorities among IATA and WWACG. The material also clarifies the term of



"holistically" which means that all types of requests should be treated equally and have fair access to all times of the day.

④ Finally, he gave the graphic presentation as to how new entrant requests, non-new entrant requests and requests for changes to historic slots should be allocated as an example. However, as this graphic presentation only reflects his interpretation of new priority scheme, no printed materials were circulated. He mentioned that he would try to seek solutions as soon as practical how to allocate slots in the new priority scheme, as there was no consensus even among WWACG board members.

### 5. Agenda Item 4: WSG New Governance (Worldwide Airport Slot Board)

Mr. Takeda reported the WSG New Governance using the material shown in Appendix 4.

He reported how the WSG governance has evolved.

① Memorandum of Understanding (MOU)
MOU was signed by ACI, IATA and WWACG in June
2019 to develop the modification proposals on WSG

jointly.

② Agreed items in MOU

He reported the agreed items among three parties shown below:



- The name of WSG should be changed to WASG (Worldwide Airport Slot Guidelines).
- Modification of WASG should be made jointly by IATA, ACI and WWACG.
- WASB (Worldwide Airport Slot Board) will be established to discuss the modification proposal.
- WASB should be composed of 21 members; 7 airlines, 7 airports and 7 coordinators. 7 airlines will be appointed by IATA, 7 airports will be appointed by ACI and 7 coordinators will be appointed by WWACG.
- 1 Chair and 2 Vice-Chairs will be selected from each industry group.
- WASB will meet at least 3 times; 2 at IATA Slot Conference and 1 at ACI meeting.
- ASWG (Airports Slot Working Groups) will be established to discuss the technical details and make proposals to WASB.
- WASB should work on the basis of consensus regarding the modification proposals. If consensus cannot be reached, the proposed changes must be approved in the form of a majority of each of industry group present and voting.

The structural organization of WASB is shown to the right. 7 nominees from WWACG have been determined at the election of WWACG. 7 nominees from IATA is almost ready. ACI is still under the deliberation.

③ Timeline of WASB

He lastly showed the timeline of implementation of WASB. Final member of WASB will be determined by the mid December, and the first WASB meeting will be held in March in Kuala Lumpur where ACI 12<sup>th</sup> Annual Airport Economics & Finance Conference will be held.



## 6. Agenda Item 5: SHL & SAL Distribution

Mr. Takeda briefed the meeting of the SHL and SAL dates at WWACG Web Site using the material shown in Appendix 5.

At first, he mentioned the reason why he took up this topic. He received some complaints from Asian Carriers as well as his home carriers that there are some coordinators in Asia/Pacific region who sent neither the SHL nor the SAL even after the both deadlines. So, he checked the WWACG website

regarding S20 SHL and SAL dates.

He found that only 8 organizations uploaded S20 SHL date out of 19 organizations (42%) and also found that only 9 organizations uploaded S20 SAL date out of 23 organizations (39%). This is very low profile

compared with other region, especially, coordinators in Europe uploaded the SHL and SAL date almost 90%.

There are still some organizations who have not registered their ID & PW, and who have not uploaded SHL & SAL dates at WWACG web site even though they have ID & PW.

He reminded the participants for those who have not registered their ID & PW to do it immediately, and for those who have already ID & PW to upload those dates as soon as possible.



## 7. Agenda Item 6: Hong Kong Historic Dispensation

Miss. Birdie Yuen (Hong Kong Schedule Coordination Office (HKSCO)) provided a brief on the 80/20 waiver as a result of the recent disruptions at HK International Airport using the material shown in Appendix 6.

She explained that many flights were cancelled due to significant drop in demand. Following the request of IATA and airlines, HKSCO has waived the "use-it-or-lose-it" rule for all cancellations after August 2019 in S19. All slots after 1 August were considered as operated in the calculation of 80% usage.

In the Scheduling Advisory Committee meeting held in Hong Kong in September, it was discussed and agreed that the "use-it-or-lose-it" rule will be suspended for the whole W19. The slot holdings and the associated night quotas (QCs) as at the baseline date of W19, ie. 2359Z on 31Aug 2019 will form the base of W20 historic. Any new slots cleared with immediate effect will not be entitled for historic right in W20, but will have higher priority if operated 80%.



She went on to report the instances of previous dispensations granted at HKG. Similar waivers were given in S03 due to SARS and in S09 due to economic crisis along with other slot coordinators. She appealed to other coordinators to also consider facilitating airlines' requests on the waiver amid this challenging time.

## 8. Agenda Item7: Any Other Business

(1) APACA Election at SC146 (Montreal, June 2020)

Mr. Takeda reported that the current term of service as chair and vice-chair for APACA will end by the next

June. So, there should be an election at the occasion of SC146 to be held in Montreal, Canada. He is planning to send the call for election for APACA to all the members around next April. He asked the participants to nominate himself or herself to be chair or vice-chair of APACA.

#### (2) Revision of data base

Mr. Takeda reported that the database for each coordinator or facilitator was not updated for almost 10 years. The data base includes the outline of organization, airport details and statistical data of aircraft movements and air passengers. He will send the draft data base to each member so that the contents will be updated by each member. He asked the cooperation of each member.

#### (3) Singapore Third Runway

Mr. Donald Tan (Changi Airport Coordination) briefed the meeting that from 25 October 2020 (start of NW20 season), Changi Airport will operate using Runway 1 and Runway 3. Runway 2 will be closed

temporarily for the next phase of infrastructure works for the Changi East project, which includes Changi Airport's future Terminal 5.

As Runway 3 is geographically further away from the current terminals, flights using Runway 3 will experience longer taxi times compared to under the current Runway 1 / Runway 2 configuration. The predominant mode of operations during Runway 1 / Runway 3 operations would be arrivals on Runway 1 and departures on Runway 3. This is similar to the current mode of operations where



Runway 1 and Runway 2 are predominantly used for arrivals and departures respectively. As such, airlines can expect several minutes of increase in average taxi-out duration, while taxi-in duration is expected to remain similar to today.

In view of the longer taxi-out times at Changi Airport from 25 October 2020, airlines have been advised to consider the need to adjust the slot timings of their existing flights at Changi Airport. Singapore will treat the approved adjusted slots as the new historics, subject to slot adherence rules. As airlines may also adjust their slots at downstream airports, Mr. Donald Tan sought the support of the Asia Pacific coordinators to facilitate these adjustments at their respective airports where appropriate.

#### (4) Asian Tea Gathering

Ms. Petra Popovac announced that Asian Tea Gathering would be hosted by Airport Coordination Australia (ACA). Tea Gathering would take place at room "M2" on Mezzanine Level, Brisbane Convention & Exhibition Center (BCEC) during a lunch time from 12:00 to 13:00 on 14 November (Thursday). The participants were invited to join the gathering.
