

<Notice for W25 Submission for NRT>

1. Runway:

1) Hourly rate

From 0600 to 2255, movement counts of runway A and runway B are combined.

From 2300 to 2355, aircraft can arrive and depart, using runway A only.

2) Noise sensitive hours (After 2200)

From 2200 to 2255, a maximum of 10 movements are designated to use runway B by Narita International Airport Corporation (NAA) after slot allocation done by JSC.

Only aircrafts categorized as "Noise Index A/B/C" by NAA can land or take off after 2300. It is the responsibility of airlines to check the rating of Noise Index before or after slot allocation. The Noise Index rating is based on the certificated noise levels of an aircraft relative to the ICAO Chapter 3 standard, which may vary widely according to aircraft type, weight, engine type, and other configurations. For precise Noise Index rating, submission of certificated weight and noise data to NAA is required.

\*All times are shown in Japan Local Time

2. Parking stands

In case of overflow of capacities, alternative timings may be allocated.

It is recommended to send Initial Submission with the actual aircraft type that is planned to be used throughout the season.

That is because the application for upsizing aircraft type may not be accepted after the initial coordination, depending on the usage of spots.

3. Initial Submission

A. 15MAY (16MAY 08:59 Japan Local Time) is the deadline for W25 Initial submission.

B. The additional criteria will be taken into consideration for changes to historic slots that were:

I Retimed or added on an ad-hoc basis during W24\* (i.e. Slots whose SHL was given at a different time from the operated timing)

I Complied with the minimum utilization requirement\*\* during W24

I Requested again in the initial submission for W25 with the same timing operated on W24 on an ad hoc basis.

\*The series of slots retimed or added during W24 should not be split throughout the season.

\*\*A series of slots at least 5 slots allocated for the same time on the same day-of-the-week satisfied the minimum 80% usage requirement.

**Please state flight number and the day of operation in SI field of your initial submission** with reference to below example\*\*\*, if you want JSC to take into consideration above criteria. JSC will check if your request meets the requirements.
